1. Purpose of Prequalification of Health Facility Design Consultants (HFDC)

The prequalification of Health Facility Design Consultants (HFDC) is a further initiative by the DHA Health Regulation Sector to ensure new Health Facilities within Dubai are designed to the appropriate standards by competent HFDC. Furthermore, they will give the Dubai Health Authority confidence that the design outcome will be in line with the expected Standards and Guidelines which will reduce the processing time of the Health Facility Approval Process

Subsequently, this process will benefit the Investors to select a competent consultant specific to Healthcare Services categorized to the level of complexity of the Healthcare Facility.

2. Prequalification Criteria of Health Facility Design Consultant (HFDC)

The Prequalification Criteria for the is developed based on the Best Industry Practices. The DHA Health Facility Guidelines - Health Facility Design Consultants Prequalification Application Form has been taken into consideration while preparing an enhanced & comprehensive criterion for uniformity of submission of Prequalification Document by Health Facility Design Consultants. Additionally, scoring sheet has been prepared based on the following Weightage.

3. Requirements for Health Facility Design Consultants (HFDC) to be Prequalified

- Health Facility Design Consultants (HFDC) will be prequalified based on DHA's analysis
 of documents submitted in line with the criteria mentioned in **Attachment A**
- The consultant will be assessed on the number and type of Health Facilities designed and completed. The size and complexity of the Health Facilities will also be taken into consideration.
- 3. Health Facility Design Consultants (HFDC) is required to submit CV's of key individuals with relevant experience.
- 4. Health Facility Design Consultants (HFDC) is required to hold a Professional /Trade license in Dubai
- 5. An individual having the required Healthcare experience will be prequalified subject to tieup with Prequalified Health Facility Design Consultants (HFDC)
- Any Prequalified Consultants registered with the Department of Health in Abu Dhabi will
 be automatically registered as prequalified Consultants at the DHA subject to submitting
 Professional /Trade license in Dubai.
- 7. Minimum Score required by the Health Facility Design Consultants (HFDC) to Qualify shall be **60%**





4. Categorization of Health Facility Design Consultants (HFDC) based on Experience.

The Health Facility Design Consultants are categorized based on the complexity of the facility as type 1 & type 2 as illustrated below. This is in line with the categories defined in the DHA Health Facility Guidelines.

5. Frequency & Duration of Prequalification Approval

- Dubai Health Authority prequalification for the current Category, will be valid for a period of 3 years after approval, following to which the Health Facility Design Consultant (HFDC) is required to apply for renewal with the criteria listed in Attachment A
- During the period of validity, the Health Facility Design Consultants (HDFC) are required to inform Dubai Health Authority of any major changes to the information supplied to them on the prequalification submission including changes to directorship and departure of key specialist staff if any.
- 3. In the case of Health Facility Design Consultants (HDFC) needs to apply the changes from Category 1 to Category 2, then the Health Facility Design Consultants (HDFC) will be required to request for the change with providing evidences of accomplishing Facilities of Category Type 2 mentioned in **Section 4** of this Report.
